Energy efficiency policy

1. Do not overheat

Never cover radiators or other heating bodies with textiles, furniture, etc. The more unobstructed view a radiator has of the rest of the room, the better and more cost- effectively it will heat it.

2. Air Conditioning Units

Use air conditioning units on the hottest days of the year (23°C to 25°C). Air conditioning can also be used for heating (within the range of 20°C to 21°C), if equipped with this feature. Proper ventilation and the use of air technology can save a significant amount of energy on heating. Ventilate briefly and intensely, do not leave windows and doors open. Use air technology judiciously, turn it off when not needed.

3. Report faults in time

Report any detected faults (leaking water, unsealed windows, doors that do not close properly) immediately to the facility management at the following numbers: Chy ne 602 729 0 10; Chlumec 602 731 824; Lipnice 601 122 540; Lysa 725 490 247; Lutonina 727 984 867. Likewise, report faults on electrical appliances to the facility management.

4. Turn off appliances you are not using

If you are not currently using an appliance, turn it off. If not necessary, do not leave it in standby mode. This also applies to mobile phone chargers (even a charger not connected to a phone consumes electric energy and converts it to heat).

5. Turn off the lights

Regulate the intensity of lighting! A tip you surely know – lighting consumes a significant amount of electric energy, i.e., when leaving a room where you will no longer be active, TURN OFF the lights!

6. Always use appliances according to the instruction manual

Improper handling or usage can, among other things, lead to increased energy consumption! In the case of using direct heaters, it is necessary to strictly follow the operating instructions, not to leave the appliance turned on unattended, and not to place it near flammable materials, especially textiles, blinds, etc.

7. Save water

Do not let water run freely if you do not need it. If you let the water run, you can waste an average of up to 9 liters of water per minute. Report dripping taps or leaking toilets as faults to the facility management.



8. Save office paper

Ecologically, energetically, and financially costly is the nonsensical printing of emails and other documents that can be read and processed directly on a computer monitor.
